Food Vendor Guidelines

- The Festival Coordinators reserves the right to assign booth space and location, no exceptions.
- All Food Trucks, Trailers, Concession tents, etc. should be self-contained. No water or electricity will be provided in designated area.
- The “leave it as you found it” rule prevails. Each vendor is **responsible for disposing of all trash** generated in your area at designated trash receptacles. Food Vendors are not to dispose of grease in trash cans, storm sewers or on the grass. Improper disposal of grease will result in a fine being levied against you and exclusion from future festivals and State parks Please bring something with you to dispose of the grease.
- Food Vendors will display a menu with prices and will sell **ONLY** those items listed in their signed application.
- Set up and take down is the responsibility of the vendor. Set up times are as follows: Saturday 8:30 am to 10:00 am. All Food Vendors must remain on site and participating until 4:00 p.m. Spaces will be assigned upon arrival. No early take down is permitted.
- Each exhibitor is responsible for collecting a 8% sales tax and sending it to the state at the conclusion of the show. Forms will be provided by event coordinators the day of festival.
- It is the responsibility of the exhibitor to have an acceptable liability insurance necessary to operate.
